The Chair invited the Deputy Chair Derek Williams to present the FY23 Financial Overview.

- Community lands dropped in value by approx \$1.4m. However, this will not impact the Trust's ability to make grants. Properties in Whanganui and Greytown have increased by approx \$75k, and rents were at market rates.
- Minor capital works while some maintenance is able to be deferred, there are conservative provisions in place and the focus is on preserving assets.
- 2021 managed funds due to the falling economy this has been tumultuous, however at 31
 July investments are positive. The diversity of investments provides good security to the
 Trust.
- Consultation for lands The Trust spent less than expected on property consulting fees and maintenance. The Trust's operating expenses are at or below expectations.

Overall, there is a diverse range of assets and Trustees have planned conservatively for the unexpected and feel reasonably well prepared for potential unstable times in the future. The Trust is in good shape, with a well-diversified asset base.

The Chair spoke to the grants made for the year ended 31 March 2023.

Strategic Plan

The Chair noted that the current Strategic Plan is in its final year, the strategy will be renewed and a new strategy will be developed that is fit for purpose. The Trust has begun work on policies and practices to attract legacies and bequests.

Noted that the FY24/25 will have increased community-funded grants budget from \$107k to \$160k. There will be some community engagement in balancing the level of the grants.

The Chair thanked the Trust Manager and other supporting people to the Greytown Trust Lands Trust, tenants, Greytown residents and community groups.

5. Community Funding Presentations
