

Chair and Trust Manager Year End Review and Update



F23 Year in Review

- This year we have produced an Annual Report to better communicate and inform our results and activity.
- In October last year three of our Trustees retired –
 Catherine Rossiter-Stead, Sid Kempton and Derek Wilson.
- Three new Trustees were elected Derek Williams, Andy Holmes and Stephen Meyrick.
- In November last year we celebrated the Trust's 150th anniversary with a function at Cobblestones Museum.
- We had almost 100 guests past Trustees and employees, tenants, members from community groups and local councillors.



F23 Year in Review

- Following the election of new Trustees last October and based on the feedback from the Community Consultation, the Trust resolved to change the way in which its Community lands are leased to improve their delivery of value to the wider community.
- The proposed changes are still being progressed with the respective parties.
- In the meantime, the current leases (as detailed in the financials) and the 100% rent remission arrangements are still in place.

- We will look at our strategy around property and borrowing to enable us to capture opportunities when the time is right.
- We remain focused on building value and resilience into the Trust.

Looking Forward

- Next year sees us coming to the end of our current 2021-24 Strategic Plan.
- We will begin the process of reviewing and adapting the plan.
- Our approach is to plan realistically taking into account what we currently know, the needs of our Community, our understanding of relevant property and investment market trends and expectations.
- We will focus on opportunities to grow the size of the Trust fund through investment and if it proves possible by attracting legacies and bequests.
- Our community funding budget for our 2024/25 year will increase to \$160,000.
- We will engage with the Community about our future direction and particularly to help us understand what balance we should strike between smaller grants and grants to projects of larger scale/impact.
